

BYLAW 2016-02

A BYLAW TO PROVIDE FOR THE REGULATION AND CONTROL OF THE CENTRAL BUTTE CEMETERY.

The Council of the Town of Central Butte in the Province of Saskatchewan enacts as follows:

This Bylaw may be cited as the "Town of Central Butte Cemetery Bylaw".

Location:

All Lands acquired by the Town of Central Butte and set aside for the interment of the dead or in which human bodies have been buried, and described as follows:

That part of the South-East quarter of Section 29, Township 21, Range 4, west of the 3rd meridian, in the Province of Saskatchewan, acquired by the municipality for cemetery purposes as approved by the Registrar under the Cemeteries Act shall be hereby appropriated as a public cemetery to be called the Central Butte Cemetery.

1. General Regulations:

- a) No grave for the burial of an adult shall be less than six feet in depth from the surface of the ground surrounding the grave, and no more than one body per grave shall be allowed, except however a maximum of two ash remains may also be interred. Cremains will be buried under the monument if the interment of the cremains is to take place first. Three ash remains may be interred with no interred body in the following order: head. middle and foot.
- b) No interment of cremains or remains is permissible except within the plot acquired by the licensee for that purpose.
- c) Cremains shall be buried no less than two feet in depth from the surface of the surrounding ground,
- d) The Town or any official thereof shall not be held responsible for any mistakes resulting from lack of precise instructions regarding the grave space where an interment is to be or has been made.

e) If a licensee requests the municipality to open and close a grave at least 3 days' notice shall be given.

2. Licenses:

a) The Town may grant a license to any person for the exclusive use by him, his heir, his executor, or administrator of any plot or grave or any other person upon written approval from the original licensee, his heir, executor or administrator. The said license is to be subject to all the provisions of this bylaw and amendment thereto or any regulation passed from time to time by the Council.

b) The fees for the purchase and opening of graves at the cemetery shall be in accordance with the rates set out in Schedule "A" attached to and forming part of this Bylaw, or as may be amended from time to time.

c) No grave shall be used for any other purpose than for the burial of the human dead, nor for the burial of any person other than the licensee or his/her immediate family.

3. Monuments and Markers:

a) All monuments, markers and foundations shall be installed entirely within the plot for which it was intended.

b) All monuments and markers shall be constructed of granite, marble, bronze or other material approved by the Administrator of the Town of Central Butte.

c) Monuments or markers may be placed in Blocks 1,2,3,4,or 5 of the cemetery. Flat markers only will be allowed in Blocks 6, 7 or 8.

d) Grave covers of any kind are prohibited.

e) The licensee of a plot shall obtain a permit from the municipality prior to placing a marker or monument thereon. The permit shall be in Form 1 Appendix "B" , attached hereto and forming a part of this bylaw.

f) The Council of the Town of Central Butte may direct the removal of any markers placed contrary to this bylaw.

g) It shall be lawful for the licensee or his agent to place markers, monuments or flowers in accordance with the provisions of this Bylaw but unlawful to plant trees and shrubs.

4. Records:

a) The Administrator shall keep an accurate record setting forth the name) the location of burial, and the date of burial of the deceased person.

5. Penalty:

a) Any person guilty of an infraction of this Bylaw or any part thereof shall be liable upon summary conviction to the penalties prescribed by the General Penalty Bylaw of the Town of Central Butte.

6. Repeal

a) Bylaws 23/03, 55-11, and 5/98 are hereby repealed.

\$75.00

Grave Closing for Urn on Weekends and Holidays:

\$125.00

Graves will not be opened or closed by the Town of Central Butte from October through May.
